Superintendent Willard reported on a phone call received from Southwick Resident Steven Putnam regarding a fourth individual, Richard Power, who was a student at Southwick High School and killed in action in Vietnam. Mr. Putnam understands that the District will be unable to recognize Mr. Power with a plaque at the May 21, 2018 dedication but asked that the District investigate the possibility of recognizing Richard sometime in the fall. Mr. LeBlanc reported that he did some research in student records and confirmed that Richard was a student at Southwick High School but appeared to leave school in his senior year and entered the military and was killed in action shortly thereafter. The Committee agreed that they would like to recognize Richard and his sacrifice. The next steps are for the Policy subcommittee to review and perhaps do a recognition at Veteran's Day in the fall of 2018.

Kindergarten Enrollment Age

Mr. Houle stated that he received a request from a parent to make an exception to the Kindergarten entrance age. Policy JEB Entrance Age states "Children who will be five years of age before September 1st of the school year during which they wish to enroll will be eligible to enter kindergarten in September". The parent is requesting that their child, turning 5 on September 4, 2018, be able to enter kindergarten for the 2018/2019 school year. The Committee members discussed entrance age at other districts and how they compare to Southwick-Tolland-Granville RSD and agreed that they had no interest in making any exceptions to the policy.
