MASSACHUSETTS CIVICS PROJECTS

As required by Chapter 296 of the Acts of 2018: An Act to Promote and Enhance Civic Engagement

CHAPTER 296 OF THE ACTS OF 2018

Signed into law by Governor Baker on November 8, 2018, Chapter 296 of the Acts of 2018 is a law to promote and enhance civic engagement and support implementation of the History and Social Science Curriculum Framework.

The law includes these provisions:

- Each public school serving students in grade 8, and each public high school, shall provide not less than one student-led, non-partisan civics project consistent with the History and Social Science Curriculum Framework for each student
- A Commonwealth Civics Challenge, subject to appropriation, will be available to grade 8 students to showcase student-led civics projects; guidelines for this challenge will be released in Winter 2021, with the first Commonwealth Civics Challenge occurring in the 2022-2023 school year (subject to appropriation)

The law also authorizes:

- A **Civics Project Trust Fund** to assist with implementing history and social science and civics education, particularly in underserved communities, subject to appropriation
- Promotion of youth membership on municipal boards, committees and commissions by the Secretary of State
- A non-partisan high school voter challenge to be established by the Secretary of State in consultation with DESE.

TIMELINE FOR IMPLEMENTATION



The Department's expectation is that districts fully implement the civics projects in the 2020-21 school year, which includes engaging all 8th graders in the project as well as providing the project to all students once in high school. **SRS will complete the high school project in Grade 12 ELA.**

The Department will collect information on local implementation of student-led civics projects via SIMS reporting in Spring 2021.

HIGH-QUALITY CIVICS PROJECTS...

- Are student-led, project-based, real-world, inquiry-based, understanding of systems impact, goal-driven, non-partisan, process-focused, and action-based.
- Include six stages for civic action including:
 - I. examining the self and community
 - 2. identifying a focus issue
 - 3. research and investigation
 - 4. developing an action plan
 - 5. taking action
 - 6. reflecting and showcasing
- Ask students to...
 - Apply civic knowledge, skills, and dispositions to engage with the process of creating social and political change.
 - Conduct sustained inquiries
 - Develop and practice literacy skills digital media literacy
 - Develop and practice social-emotional learning skills
